Dated:- 26.09.2017

Sequel to the approval of the Chairman to the resolutions passed by the State Affiliation Committee in its meeting held on 25.08.2017 in the Conference Hall of JK BOSE Campus Rehari colony Jammu, sanction is hereby accorded for grant of extension in the period of affiliation in favour of **186 Private Educational Institutions (156 Institutions of Jammu division and 30 Institutions of Kashmir Division) and affiliation/upgradation in favour of 17 Private Educational institutions(12 Institutions of Jammu division and 05 Institutions of Kashmir Division)** for a period of five(05) years, as per the details reflected in the Annexure "A" and "A1" of the above mentioned Order. However, this order shall be subject to the following conditions.

- A. The affiliation shall strictly be governed by the terms and conditions as laid down vide SRO 123, relevant Govt. orders, BOSE regulations and the resolutions of the State Affiliation Committee meetings passed from time to time.
- B. That the minor deficiencies listed in the joint inspection report/s, reflected in the said annexure against each institution are to be addressed urgently before starting of Class work. The compliance to this effect will be monitored by the joint re-inspection teams as and when required.
- C. There shall be no compromise with safety conditions, therefore three mandatory Statutory Certificates viz Building safety, Fire Safety, and Chemical Safety by the designated authorities are essential for the consideration of the affiliation and the institutions concerned shall be required to submit renewed certificates immediately after expiry of the validity period of said Safety certificates besides the compliance to NBC(National building code) norms are to be ensured.
- D. It shall be binding upon all the Institutions to fulfill all the statutory conditions laid down from time to time.
- E. The financial transactions especially the payment of salary to the Staff is to be made through Bank.
- F. Fee structure to be adopted by the Institutions must strike compliance to the decisions of Fee Fixation Committee constituted by the Govt. in pursuance to the directions of the Hon'ble High Court.
- G. All schools have to comply with the conditions mentioned in the NOCs by the competent authorities. In particular they shall comply with the NOC conditions imposed by the Traffic Department for the safe transportation of Children's, boarding/De boarding arrangements of Children and deployment of the personnel for the purpose.
- H. The heads of the affiliated Institutions shall keep their infrastructure like the Examination hall and related facilities at the disposal of the BOSE as and when needed and especially at the time of the examinations.

- I. The Academic calendar prepared by the BOSE is to be strictly adhered to. Any deviation thereof will invite imposition of penalty.
- J. It will be obligatory to stick strictly to the curriculum adopted by the BOSE for all classes and prescribe Books published by the JKBOSE for transaction the Curriculum proper arrangement for co-curricular and extra-curricular activities for the students must be ensured.
- K. To maintain hygiene and sanitation, separate Toilets have to be there for boys and girls. An additional facility of Change room is to be made available to the Girl students with first Aid facilities.
- L. Parent Association as required under Norms has to be there to ensure joint monitoring along with Managing committee for the Academic development of the Students and the implementation of the decision that are being taken for their further improvement.
- M. The EFP/CPF (whichever is applicable) is to be maintained with the required contribution towards the fund.
- N. It shall be obligatory upon all the affiliated academic Institutions to obtain recognition Order from School Education Department.
- O. It shall be obligatory upon all the affiliated academic Institutions to necessarily appoint trained teachers with requisite qualification i.e D.Ed or B.Ed. hence onwards and ensure that the already appointed untrained teachers shall acquire required qualification before April,2019, as envisaged by the Government. To this effect the Institutions shall be required to submit an affidavit that the needful will be done within the stipulated time period on requisite terms.
- P. In addition to the above, the Inspection of the Academic Institutions will be caused on yearly basis and the above period of affiliation shall be reviewed annually on receipt of Inspection reports.

The observance to above mentioned requirements is obligatory and any deviation thereof will invite penalty, even de-affiliation from JK BOSE.


