ORDER NO:-34-GEN OF 2023

Subject: "Grant of Extension in the period of Affiliation in respect of Academic Institutions of Kashmir Division, having submitted their case files via Offline mode prior to the inception of the Online mode, i.e., before 01-08-2021."

Reference: "Minutes of the Affiliation Committee meeting, for offline cases held via circulation in the month of December, 2022-January, 2023".

In continuation to Order No. 03-Gen of 2023, dated 06-01-2023 issued in respect of 159 Academic Institutions out of 219 Academic Institutions, in pursuance to the Resolutions passed by the Affiliation Committee concerning Offline cases at its meeting held via circulation, and sequel to the approval, sanction is hereby accorded to the grant of:

- i) Extension in the period of affiliation for a period of (05) Five years, in respect of (04) Four Academic Institutions, as per the details given in Annexure "A" to this Order.
- ii) Extension in the period of affiliation for a period of (05) Five years, in respect of (05) Five Academic Institutions, having minor/major deficiency(ies), subject to the condition that these Academic Institutions' shall overcome the listed deficiency(ies) within (03) Three months, as per the details given in Annexure "B" to this Order.




Terms and conditions:-

- a) The grant of Affiliation, in respect of the Academic Institutions as listed in Annexure "A" and "B", shall be subject to the outcome of the Court case(s), pending adjudication before the Hon'ble Court(s) of Law and are also subject to the revalidation of appropriate Lease Deed(s) by the concerned Competent Authorities, as the case may be.
- b) The previous period of Affiliation in respect of the Academic institutions in whose case provisional facilities have been released is regularized, with the condition that the concerned Institution/s shall deposit the prescribed Affiliation fee for each corresponding year.
- c) That the Affiliation shall strictly be governed by the terms and conditions, as laid down in SRO 123 read with 292 and other relevant Government Orders, JKBOSE Regulations and Resolutions of the Affiliation Committee, as prescribed/passed from time to time.
- d) That the deficiencies as reflected against the concerned Academic Institutions shall be addressed within a time frame of (03) Three months, from the date of issue of affiliation Order, failing which their affiliation shall be re-visited.
- e) That the grant of Extension shall be subject to the production of the revalidated Managing Committee and other Safety Certificates viz. Chemical Safety, Building Safety, Fire & Emergency/ Pollution/ Health & Sanitation/ Traffic management NOC/ Lease Deed from the concerned Department/ Competent Authority, within a period of (03) Three months.

- f) That all the Private Academic Institutions shall be under an obligation to adhere to the fee structure, as fixed by the Fee Fixation Committee, failing which their affiliation shall be liable to suspension/termination without any further notice.
- g) That the Academic Institutions shall keep their premises including Examination Hall(s) and other related infrastructure/facilities at the disposal of JKBOSE, during the course of Examinations or as and when asked for and ensure necessary Heating & Cooling arrangements at their respective Institutions.
- h) That all the Academic Institutions shall strictly adhere to "JKBOSE Curriculum" for all the Classes and also adopt the Books and Academic Calendar prescribed for the purpose by the J&K BOSE. Deviation, if any, in this behalf shall invite imposition of penalty.
- i) That all the Academic Institutions shall necessarily ensure proper arrangement for co-curricular and extra-curricular activities.
- j) That the Academic Institutions, in order to maintain proper hygiene and sanitation, shall ensure separate Toilet facilities for Boys and Girls, in addition to "Change Room facility", in respect of female staff and students, besides, ensuring the provisions of the adequate purified drinking water facilities by installing quality Water Purifier/s in the school premises.
- k) That in order to ensure academic development, all the Academic Institutions shall include and nominate at least one member from their Parent Association in the Managing Committee.
- l) That the financial business including payment of salary to the staff shall be made by the Academic Institutions through the Nationalized Banks only and also remit the EPF/CPF (whichever is applicable) with the required contribution of the employee and the employer, with the concerned authority.
- m) That the Heads of the Affiliated Academic Institutions must upgrade their Science Laboratories, Computer Laboratories and the Libraries as per the present day requirements and in pursuance to the prescribed guidelines.
- n) That the academic institutions shall follow the RTE Act, 2009 and the instructions issued thereof by the UT Government from time to time.
- o) That the managements of the concerned academic institutions shall be required to acquaint themselves with JKBOSE Regulations, Notifications,/Circulars issued by the JKBOSE from time to time for the purpose of the Affiliation and the respective Examinations.
- p) That the academic institutions shall be solely responsible for any legal consequences arising out of the use of School name/logo/society/trust or any other identity or any false, forged or misleading information, as provided to this office.
- q) **That all the Academic Institutions shall strictly ensure submission of case(s) for grant of Extension in the period of Affiliation one year ahead of expiry of their term of Affiliation, failing which late fee, as admissible under rules shall be levied from the defaulters.**


