All the required details for registration are as follows:

Registration Process:

To become a registered bookseller with JKBOSE, follow these simple steps:

Step 1: Application Submission on prescribed form:

Prepare a straightforward application addressed to the in-charge Textbook JD/KD, expressing your interest in becoming a registered bookseller and submit the prescribed form.

Step 2: Photographs:

Attach two passport-size photographs to your application.

Step 3: Affidavit:

Include a duly signed affidavit confirming your commitment to ethical business practices.

Step 5: Aadhaar Copy and PAN, GSTIN, Shops and establishments certificate:

Furnish an attested photocopy of your Aadhar card, PAN card and GSTIN.

Step 6: Registration Charges:

Deposit a minimal fee of Rs. 1000/- registration/re-registration every year.

AGREEMENT

1. This agreement is made and executed on this _____ day of _____ between Secretary, J&K board of School Education (Herein after called “ The Board” on one part and _____ S/o _____ R/o _____ Carrying business under the firm name and Style _____ (herein after called the sale agent) on the other part.

TERMS AND CONDITIONS

2. The date of execution of this agreement shall be the commencement date and the agreement shall remain valid and binding until it is revoked by either party in writing or for a period of one year whichever is earlier.
3. The Sale agent/ Bookseller shall ensure that the books sold are of authentic/original and are not spurious, fake, counterfeit, pirated copy etc. Whatsoever. The sales agent agrees to replace the defective products supplied to the customer at its own cost and shall not hold the Board responsible in any manner whatsoever.
4. The sale agent shall ensure the condition of the books before taking delivery and no replace subsequently shall be permissible on account of any defective condition of the books. For avoidance of doubts it is clarified that defective would mean and include but is not limited to wrong product, damaged product, mis sized product and any other shortcoming which the customer may point out.

5. The sale agent will not indulge in any act/ deal in a thing/ products/goods/services which are either banned/prohibited by law or violates any of the intellectual property right of any party in respect of such product.
6. The sale agent/book seller agrees not to provide any such description/ information regarding the product which amounts to misrepresentation to the customer.
7. The sale agent/bookseller shall at all times be responsible for compliance of all applicable laws and regulations including but not limited to intellectual property Rights, goods and service tax, Standards of Weights and Measures legislation, Sale of Goods Act, Code of Advertising Ethics, etc. To provide to the Board copies of any document required by the Board for the purposes of performance of its obligations under this agreement with 48 hours of getting a written notice from the Board.
8. The Sale agent/books seller has no proceedings pending, which may have a material adverse effect on its ability to perform and meet the obligations under this Agreement.
9. The Board at the request of the book seller registered/agent has agreed to appoint him to be the Registered JKBoSE, authorized bookseller for the sale of textbooks only prescribed, printed and published or distributed by the Board on the terms and conditions settled between the parties.
10. The Board shall from time to time during the terms of

One year commencing from _____ consign and supply textbooks and in such quantity as they may be the stock position in the stores for disposal at the moment, keeping in view the demands for such textbooks/ Publications from other quarters at the moment.

11. The Registered bookseller/agent shall use his best endeavor to sell and dispose off the books supplied to him hereinafter stated at the price fixed by the Board from time to time and shall in the meantime keep the books in his shop at a proper place and in a proper condition at his own risk and responsibility.

12. The agent shall sell the textbooks/ Publications at the prices indicated on them or notified by the Board, in no case the rates more than what has been published on the textbook shall be charged from Student community.

13. That the Registered Bookseller/sale agent should keep all the textbooks of Board Publication available at his shop throughout the year. In case the agent does not keep all textbooks available at his shop throughout the year, the Board shall without previous notice to the agent blacklist him unless provided with a sufficient reasoning.

14. The Registered bookseller/sale agent shall neither arrange binding of Board publication nor sell Board Publication binded by some other party.

15. The Registered bookseller/agent shall sell Board Publications after affixing seal of his/her shop on them.

16. The Registered bookseller/agent shall at all the times during the continuous of the said agency obey and observe all directions and instructions which may be given to him/her by the Board, concerning the sale and disposal of Books or otherwise relating to the Business of the said agency.

17. The Registered bookseller/ agent shall be furnishing the requisition of cash security.

18. The Registered bookseller/agent shall deposit Rs 1000/- as registration/renewal Registration fee.

19. The Registered bookseller/agent shall make his own arrangements in connection with the sale of books/ Transportation from sales counter of JK Bose to his shop or storage and shall bear all losses, damages, liabilities, debts etc., incurred or contracted by him or his employees in respect of the said sale and all costs and expenses whatsoever of advertising, circulating or selling the same shall be borne by him.

20. Either party hereto on valid reason shall be at liberty to terminate the aforesaid agency by giving one month's notice in writing to the other party.

21. The Registered bookseller/agent shall not without the consent in writing of the Board assign or in manner make over the said Registered bookseller/ agent or this contract to any other person/firm/bookseller etc.,

22. The Board hereby agree to allow discount @20% on the price fixed for the textbooks sold to the agent. Every such requisitions for the books shall be made to the Board's main stores at Srinagar and Jammu and Sub Stores at Leh and Kargil.
23. The Registered bookseller/ agent shall not be entitled to cancel or revoke any order for supply of the textbooks.
24. The Registered bookseller/agent shall not print, produce or deal with the notes of any textbooks assigned to him by the Board under this agreement.
25. The Registered bookseller/agent shall have to purchase the required publication of prescribed textbooks available at stores in such a number as may be determined by the stock position of the concerned store.
26. The Board reserves the right to reject any application for grant of any Registered bookseller/ agency or for the renewal of the agreement if adverse reports about performance reliability of the applicant have been brought to its notice.
27. The Textbooks once sold should be checked, calculated and verified for any damage, etc., at the location of Textbooks stores JD/KD and thereupon no claim shall be entertained from the Registered bookseller/ Agent.
28. In the event of any default or failure on the part of the agreement of the agent in fulfilling the terms and conditions of the agreement, the Board shall in addition to and without prejudice to its claims and remedies available to it under clause 16 or

any other law for the time being in force be competent to Blacklist the seller and terminate the agreement after 07 days' notice to the agent.

29. The Bookseller/ Agent affirms its commitment to comply with all relevant tax laws and regulations governing the sale of educational materials and shall bear any associated costs without recourse to JKBoSE.

30. JKBoSE shall not be held liable for any financial consequences, losses, or claims arising from changes in the tax slab or related factors affecting the pricing structure.

31. In the event of any dispute, difference or interpretation of terms and conditions, whatsoever arising out of or in connection with the agreement the same shall be referred to arbitration of the Chariman J&K Board of School Education or to the person to be nominated by him (chairman, J&K Board of School Education) and the award of the arbitrator shall be final and binding upon both the parties.
